Subscribing to the Recording Notification Service

- 1. Navigate to: <u>https://acclaimweb.horrycounty.org/PublicRecordsNotificationWeb/Subscribe</u>
- 2. Complete the registration form by entering:
 - a. A valid email address
 - b. At least (1) individual or business name to monitor
 - i. If you wish to monitor more than one name, or instance of a name, you may do so by pressing the "+" button near the end of the line.
 - ii. If you wish to remove a selection you have entered in error you may click the trashcan icon to delete a name from the list.

****Please note**: All names are character specific. Meaning the name you are monitoring must match the name on a document that is being recorded exactly for the name to return a hit. So DOE JOHN is different than DOE JOHN J IR, etc. When in doubt if you want to monitor a name completely then have the system monitor all instances of that name.**
