The Horry County Board of Architectural Review held meeting on Tuesday, November 26, 2001 at 5:30 pm in the Kroger Conference Room in Conway, South Carolina. ### I. Call to Order

### III. Adoption of Minutes

The Board decided to defer the minutes until the next meeting since there was not a quorum to vote on them. They decided to discuss the Little River Driving Tour brochure and the Stone House.

- IV. Update School Curriculum status Chairman Carter suggested he speak with Attorney John Thomas about getting the Historical Society involved in helping with the school curriculum. Everyone agreed this was a very good idea.
- V. A) Little River Driving Tour brochure The Board discussed the Little River Driving Tour brochure contents. There was a discussion about the layout of the brochure. Mrs. Charles said she would help with looking at the layout for it. Mrs. Poston said she would get three different printers who can help with the layout design to submit bids for it. Chairman Carter suggested contacting Electric City Printing and Printing Port of Myrtle Beach. Mrs. Poston showed the Little River Driving Tour map that Mr. Todd Wagner, Horry County Mapping produced for them. Everyone thought it was great. She talked about laying out the brochure

like the South Carolina National Heritage Corridor brochure. She explained how their brochure included a great deal of information.

Chairman Carter suggested the Board send Andrew Theilen, Director Little River Chamber of Commerce, Polly Loman, Editor, North Myrtle Beach Times, Georgia Ellis, Little River resident, and C. B. Berry, Surveyor a copy of the brochure before it goes to press since they helped out with writing it. There was a discussion about using old pictures in the brochure. Mrs. Poston shared all the pictures Mr. Danny Taylor, Horry County Planning Director had taken for the brochure. Everyone agreed they were wonderful.

Mrs. Charles said she would find out information on the Intercoastal waterway. Mr. Long said he would contact Polly Loman about finding out information on the Chianti Restaurant.

The group discussed about holding all our meetings at the Kroger Conference Room for next year since it was a central location for everyone. Mrs. Poston said she would contact Kroger and Horry County about publicizing next year's calendar.

B) Discussion about the Stone House – Chairman Carter talked about the progress being made on the Stone house. He said he met with Mrs. Poston and Mr. Don Bruton about doing the architectural drawings for the house. He showed the Board the drawings he produced for the meeting. He talked about the different details such as the brick entrance, redoing the existing porch because of water damage, fixing the roof and siding. Chairman Carter said right now there is no sheathing for the insulation. The building currently has felt and cotton insulation. He really wants to change this because an air/heating conditioning system will be installed when it is renovated. He discussed redoing all the rotted trim and eaves. He said to level the house it would be very expensive. He will be shoring up some of the foundation beams that are sagging. He said he talked with Mr. Bruton about right now covering the holes that exposes the house to the elements. For example, there is a hole where the flue for the boiler use to be that is open to the outside. He talked about the cedar shakes for the shingles. Chairman Carter is proposing talking off the roof and putting down a plywood deck, felt and shingles.

The group discussed getting different companies and individuals involved with the windows, brick, lumber, and roof. He said we really need someone who can Contract Manage the entire project during the renovation. Everyone decided the Stone House drawings need to go out for bid in mid-January so we can see how much it is going to cost and how much money needs to be raised for it. Chairman

- V. A) Little River Driving Tour brochure The Board discussed the Little River Driving Tour brochure contents. Chairman Carter discussed about getting markers or signage for each of the Little River Driving Tour brochure places. Mrs. Diane Poston suggested that we try to get grant monies for signs at the different places where we can actually put up informational markers or signs. She said Little River has wonderful Revolutionary and Civil war history. It would be a shame not to mark these places. Chairman Carter also suggested the Board investigate getting caste medallion for the places. He said the Board should hold a student design contest at the local schools. It would be a great educational tool as well as publicity for historic preservation of the homes and businesses on the tour. Chairman Carter said we might want to get a numbered marker indicating the historical place.

The Board discussed the Little River Driving Tour map that Todd Wagner, Horry County Mapping had done for them. Mrs. Linda Siceloff suggested adding the Chianti Restaurant and Essie and Copeland Lewis house on the tour. She also shared a great history about each of the relatives of the different places named in the brochure. She mentioned there was an old house at the entrance of Heather Glenn that use to have an old shed that still had slave shackles in it.

Chairman Carter said that Mrs. Poston and Mrs. Siceloff needed to drive by and see if it was still there or feasible to include in the brochure.

Mrs. Tempe Oehler suggested the exact addresses of the places listed in the brochure needed to be included at the end of each description. She said that way if anyone was lost or was having a hard time finding the place, they would have an address. The entire Board agreed. Mrs. Poston said she would get the exact address location. She said she would be sending a preliminary copy of the brochure to the State this coming week.

Mrs. Jane Charles said the information on the fact page was good but there was duplication in the brochure and the information page and one needed to be deleted. Attorney John Thomas suggested that in the descriptions about the places our student essay winners had written about to only mention the award contest once. Mrs. Poston said some of the descriptions definitely needed to be edited. The Board decided to remove all the children essay winner names from the brochure and just write strictly about the historic place.

Mrs. Siceloff asked about the St. Pauls AME Church and the original location. Mrs. Poston said she would try to get more information on it. Chairman Carter said he would try to contact the Church and find out more information also.

Mrs. Poston said the Horry County Planning Department staff is in the process of doing a Comprehensive Land Use Plan supplement and we would be going to check out the places in Little River Driving Tour brochure also.

B) Discussion about the Stone House – Chairman Carter talked about the progress being made on the Stone house. Mrs. Poston said she wanted to set-up a meeting with Mr. Don Bruton about the progress going on with the Stone House. Chairman Carter said that would be fine and he talked about what his engineer would be doing about the underpinning of the open basket weave brick foundation. He talked about the State asking to install the brick foundation to the way it was originally. There was a discussion about how low the original house was when it

was first built. Chairman Carter said it was important to try to get the house back to its original shape for future grant opportunities. Mrs. Siceloff said she would help to follow-up on the letter. Mrs. Siceloff discussed the Little River politics and history of the Stone House. She also talked about asking Habitat to maybe help out with the house.

Chairman Carter talked about holding some kind of event at the Stone House to help with its publicity in getting it repaired and renovated. He also talked about getting the historical school curriculum started and how it would be so helpful for educating the children in the area. It would be a great device to relate the local history to state and national history. Mrs. Oehler talked about her trip to the "Alamo" and all the educational activities and curriculum that was going on with their program. She will be sharing the programs with Mrs. Poston and the Board members. She said all the materials were wonderfully written.

- VI. Other Business There was not any further buisness.
- VII. Adjournment Hearing no further business, Mrs. Jane Charles made a motion to adjourn and Mrs. Tempe Oehler seconded the motion. The motion was accepted by unanimous approval. The meeting adjourned at 8:45 p.m.

III. Teaching with Historic Places Curriculum – Chairman Carter expressed his deep regrets regarding the terrorist attacks and everyone agreed how horrible the last week has been for the world.

The reason the Board decided to hold this special meeting was to discuss how the "Teaching with Historic Places" curriculum should be developed. Chairman Carter passed out an example "Teaching with Historic Places" curriculum notebook. The lesson plan included a packet on how to set-up a lesson plan in a local school system. The example lesson plan was based upon a Georgetown County Rice Plantation and Chicora Wood Plantation, two of the thousand of properties listed in the National Registry of Historic Places. Mrs. Sherry Lee, a 7<sup>th</sup> grade teacher, about helping with setting up the curriculum. Mr. Thomas suggested everyone look at the website and review lesson plans. There was a general discussion about what the curriculum should entail. Chairman Carter said a topic might be to find out why Horry County is known as the Independent Republic of Horry County. Mr. Long talked about Wade Hampton and his significance. There was another discussion about what is most significant about Horry County. Mrs. Oehler talked about Horry County being isolated because of water and barriers.

There was a discussion about choosing a segment of time in Horry County's history. Mr. Long talked about what time period to start with and both Mrs. Oehler and Mr. Thomas suggested using Mr. Charles Joyner's book, "Down by the Riverside" to get information. Mr. Carter said that he received a call from a Ms. Harrington at Coastal Carolina University. She was inquiring about possibly using the Stone House for a foundation building. He said that they would want to move it to the University grounds. Mr. Feest stated that the structure analysis showed that the house would need considerable structural work before it could be moved.

Mr. Carter distributed a letter he received from The National Alliance of Women in Construction. Mr. Feest said that he would attach to the minutes for reference.

Hearing no other business, a motion was made to adjourn at 7 p.m. The meeting adjourned.
