Per Lauren Harrelson the freeboard at this location is 3'. Regarding item B8., a portion of this property lies in a floodway. Regarding item C2. a), the elevation reported is the top of slab in the 79 square foot storage room. The elevation of the bottom of the 31 square foot elevator shaft is 5.25'. Regarding item C2. e), the elevation reported is the bottom of a utility box associated with a grinder pump on the west side of the structure. There are also HVAC units on a platform with an elevation of 17.6'.


