**Horry County Board of Architectural Review
and Historical Preservation
September 15, 2015**

The Horry County Board of Architectural Review met on Tuesday, September 15, 2015, in Multi-Purpose Room B of the Horry County Government and Justice Center at 1301 2nd Avenue in Conway, SC. The following Board members were present: Bill Strydesky, Sam Dusenbury, Jody Nyers, James Thompkins, Joel Carter, Andy Anderson, and David Jordan. In accordance with the SCFOIA, notices of the public meeting were sent to the press (and other interested persons and organizations requesting notification) providing the agenda, date, time, and place of the meeting. In accordance to the Horry County Ordinance a minimum of a twenty-one day notice was given.

Chairman James Thompkins called the meeting to order at approximately 2:30 PM.
