I. Introduction

Mr. Steve Goggans presented the Committee/Board with his agenda for the second Master Plan review meeting. The first portion of Mr. Goggans presentation involved a detailed explanation of the wetland delineation that was performed primarily from soil classification maps.

II. Historical Survey

Mr. Goggans identified a pre-20th Century Historical home site, several prehistoric sites where pottery and other artifacts have been unearthed. Mr. Goggans recommended a more extensive site intensive survey be performed to evaluate historical significance of the islands and the George Washington trail.

III. Topography

Mr. Goggans identified the variations of ground base elevations via a topographical survey map. Mr. Goggans explained that the majority of all vegetation within the boundaries of the Vereen Memorial Historical Gardens is located on the higher elevations.

IV. Access

The Board/Committee discussed with Mr. Goggans the need to provide an attractive gateway into the Gardens that could be visible from Highway 17 and complement the proposed Reception/Welcome Center. The Board/Committee reviewed the proposed site plan submitted by Councilman Skidmore. The majority of the concerns relative to the site plan involved the access questions. The Board and Committee agreed to review the site plan again after revisions were made and vote on the requested approval at their next regularly scheduled meeting.

V. Program Presentations

Mr. Goggans distributed copies of the Program recommendations to the members of the Board and Committee. The program items were suggestions from the design team that should be considered for inclusion to the master plan.

VI. Comments and Discussion

The Board/Committee discussed the access ways into the Gardens and the best flow patterns for traffic. Ms. Jane Charles requested the internal entrance road be relocated to the South of the museum area and proceed North past the Nature Center and tie back in with the Northern access road. Chairman Joel Carter requested the pond expansion and dam reflected on Scheme B be placed on Scheme A.

VII. Adjournment

Mr. Steve Goggans and Mr. Robert Marvin both requested the Board and Committee review both proposals and decide which program items should be placed on the Master Plan. Chairman Carter entertained a motion by Jane Charles to adjourn with a second by Ruth Bell with all in favor.

IV. Community/Welcome Center Site Plan

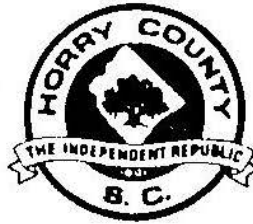

The board also reviewed photographs taken from the last field trip to inspect potential Historic properties.

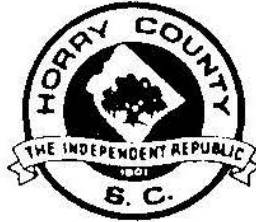

Mr. Thompson informed the Board that the list is complete with the exception of the tax map numbers critical to the enforcement and adoption process. Mr. Thompson explained that individual site visits would be required to identify each parcel containing historic structures due to the widespread locations of properties.

There being no further business, Chairman Carter entertained a motion from Ruth Bell to adjourn with a second provided by Mr. Bill Long with all in favor.

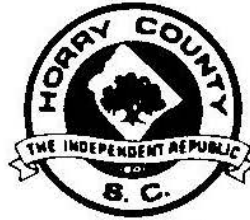

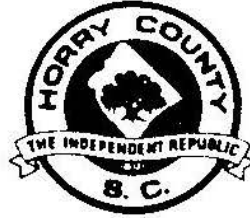

BAR MINUTES
May 28, 1991

The Horry County Board of Architectural Review met on May 28, 1991 at 6:00 p.m. in the Conference Room of the Old Burroughs School Building. Present were Jane Charles, Ruth Bell, Joel Carter, John Thomas, Tom Shaw and Nancy Merriweather of S.C. Archives and History, as well as Charlie Thompson of the Horry County Planning Department.

Jane Charles, the acting Chairperson, called the meeting to order.

The first order of business was a presentation by Mr. Tom Shaw of the S.C. Archives and History. Mr. Shaw began with an overview of the protection provided by the National Register designation as well as the requirements involved in nominating a property. Mr. Shaw also informed the Board of Horry County's current status in the nomination process. Currently Horry County has completed the background historical information required to complete the historical cover sheet of Horry's development. It was then recommended that the County acquire a Consultant to nominate individual properties due to the indepth research time, and specialized expertise required. It was at this time that the Board was instructed by Ms. Nancy Merriweather of Archives and History's 50/50 matching grants that could be available to Certified Local Governments (CLG) to assist in easing financial expenditures. Mr. Thompson was asked by the Board to request estimates from Consultants so they could access the financial feasibility of completing this project. The Board was also notified that by being designated as a National Register property, landowners would be eligible for Federal Tax incentives as well as restoration grants.

Mr. Shaw and Ms. Merriweather also recommended that the BAR begin to prepare a slide presentation and education package to illustrate the benefits to the community to encourage preservation of the County's Historic resources. The BAR was also advised to coordinate with the Horry County Council to assist in the adoption of the properties to be protected by local designation and review.

The Archives and History representatives also encouraged the Board to research local foundations and agencies that may be possible donors of funds for restoration where hardship cases are created by designation. The financial assistance is earmarked for situations where the original features are usually ornamental and elaborate in design, thus increasing the cost for reproduction of a suitable replacement.

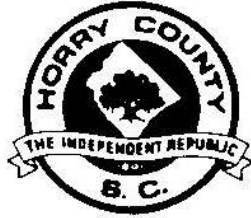

I. INTRODUCTION

Mr. Steve Goggans of Goggans and Associates introduced himself, Mr. Robert Marvin and Ms. Susan B. Robertson of Robert E Marvin and Associates to the Committee, Board Members and guests.

II. SCOPE OF SERVICES

Mr. Steve Goggans thanked all present for giving him the opportunity to work on the Vereen Memorial Gardens project and proceeded with a presentation of pre-design information. Mr. Goggans provided a flow chart visual aide to illustrate the following steps for the Master Plan:

Mr. Robert Marvin is a well renowned Landscape Architect who is responsible for many parks, gardens and community facilities design and construction offered some input to the visitors relative to aesthetic design features. Mr. Marvin stated a garden or park should be designed to address societies need for an environment conducive to the psycholocial, spiritual, emotional and physiological needs. He stated this type of environment nurtures mankind's growth which is important for societies to fully develop. Mr. Marvin also mentioned that a good Master Plan must be flexible enough to allow additional growth and development. Mr. Steve Goggans gave a summary of the type of environmental review that will be performed per the contract agreement. Mr. Goggans stated an environmental compliance level survey and a historical background research would be adequate for the preliminary investigation. He also stated that if any artifacts were unearthed during any construction a further site review would be necessary.

III. DESIGN INPUT

Mr. Goggans and Mr. Marvin requested all members and guests provide input and recommendations relative to design improvements to be planned for the Vereen Memorial Historical Gardens.

BAR Chairman Joel Carter requested an expedited review of the 3.85 acre tract located on the frontage of the Vereen Gardens, due to a plan for a 4,200 square foot building to be placed there for a reception/conference use.

The Horry County Board of Architectural Review met on April 30, 1991 in the conference room of the Old Burroughs School Building. Present were Jane Charles, Ruth Bell, John Thomas, Bill Long and Charlie Thompson of the Horry County Planning Department.

Jane Charles called the meeting to order.

The first item of business was a presentation by Jane Charles and Charlie Thompson outlining their participation in the "Share the Vision Workshop" held in Mount Pleasant April 23, 1991. Mrs. Charles explained how the workshop promoted community participation and emphasized the importance of historic education to support preservation of historic structures and landmarks in Horry County.

The second item of business was the discussion and review of the certificate of appropriateness that is required to alter Historic structures. Mr. Thompson circulated the proposed certificate of appropriateness receiving comments and corrections to enable the creation of the final draft.
