The Horry County Board of Architectural Review held their regular meeting on Tuesday, May 20, 2003 at 12:00 p.m. in the Horry County Planning Department at 1301 Second Avenue Conway SC. The following is a summary of the actions taken.

I. Call to Order

Mr. Joel Carter called the meeting to order.

II. Invocation

Mr. Bill Long gave the invocation.

III. Approval of the April 22, 2003 minutes from the regular Board of Architectural Review meeting

Mrs. Katherine Fuller made motion to approve and Mrs. Jane Charles seconded. Motion carried unanimously.

IV. Old Business:

- A. Essay Contest – Mrs. Fuller stated there were no essays submitted. Mrs. Janet Carter suggested a prize to encourage participation. One suggestion was to ask Burroughs & Chapin to donate a park pass. Mr. Joel Carter suggested a gift for recognition of the teacher also. He will speak with someone in the school district office in August to get the essay contest on the calendar.
- B. Teaching with Historic Places lesson plan(s) Status – Mr. Carter had not heard from Mr. Chris Boyle, however Mrs. Aprelle Brown was working on her topic. Mrs. Janet Carter reiterated that the goods needed to be received by June 30, 2003 in order to pay out of FY03 funds.
- C. Historical Markers for the Socastee HP District - Mrs. Thorpe had not located the wording for the markers that was thought to be in the minutes. She had spoken with someone at SC Archives & History. It was decided to order two country markers on 7-ft. posts with the same text on each side at a cost of \$1350.00 each. Mrs. Katherine Fuller made motion and Mrs. Tempe Oehler seconded. Motion carried unanimously.

- D. Socastee brochure review drafts – Mrs. Jane Charles distributed a copy of the paragraph she had written regarding the Socastee United Methodist Church. It was decided to hold a workshop on Wednesday, June 4th at 10:00 am to work on the brochure. A farewell luncheon for Katherine Fuller will be at 11:30 am at Mrs. Fuller’s home.
- E. Awards Schedule & Details – It was decided to present awards for the three buildings at the Council meeting on July 22, 2003.
- F. Budget Expenditures – Mrs. Fuller felt the applicant, not Horry County, should pay the nomination fees.

V. New Business

- A. Review of Ordinance Draft – Mrs. Thorpe distributed copies of the ordinance along with copies of the Certificate of No Effect and the Certificate of Appropriateness for review. It was a priority to reconstitute the Board of Architectural Review. The Board felt another priority should be to update the County inventory of historic places.
- B. Socastee Historic District Meeting announcement – Mrs. Thorpe stated the Socastee Historic Committee wanted to have a public meeting on July 17, 2003. Mrs. Thorpe was asked to order brochures from SC Archives & History for distribution. One was “Smiling Faces – Historic Places” and the other one was “Rehabilitation Incentives.”

Mrs. Fuller indicated Roger Stroupe had requested a bus tour of the Myrtle Beach motels of the 1960’s. She had asked someone in Myrtle Beach to coordinate this. She had also been notified that SCETV had scheduled a program in December about Horry County. SCETV would be using information from her thesis in their program.

VI. Adjournment

The next meeting was scheduled for Wednesday, June 4th at 10:00 am in the Planning Department Conference Room. Mrs. Jane Charles made the motion to adjourn and Mrs. Tempe Oehler seconded. Motion carried unanimously. The meeting adjourned at 2:00 pm.
