- II. Mr. Long gave the invocation.

Mr. Carter said that Mrs. Futrell may know of some historic African-American sites that we could include in the brochure. Mrs. Fuller stated that the brochure should contain a person/agency to contact for additional information on these sites and other historic data and suggested the Horry County Museum as a good candidate for this. Mr. Hodge said he would check with the Museum Director for his permission.

The specifics of the brochure were discussed and several examples were shown from other historic areas. Mrs. Oehler and Mrs. Charles particularly It was decided that if the price was

not significantly high, we should print 5,000-7,500 brochures. The brochure would be full color, printed on both sides, semi-glossy, 80 pound text, 12 x 18 inches in size, folded to 9x4 brochure, and include a generalized map of South Carolina and Horry County.

- V. National Register Nominations were also discussed and the following sites/districts were approved for nomination:

  - B. Galivants Ferry/Holliday Farms District
  - C. Horry County Courthouse

Mr. Hodge said that he would contact the property owners in these potential districts to ensure that we had their support before the project was begun.
