In accordance to the Horry County Ordinance a minimum of a twenty-one day notice was given.

Mr. Carter called the meeting to order. A valid quorum was present for voting purposes.

Mr. Douglas made a motion to approve minutes as amended. Mr. Burroughs seconded the motion. The motion carried unanimously.

#### **OLD BUSINESS**

# **Horry County Register of Historic Places**

**Current Status** – Mr. Emrick updated the Board on the status of the first seven properties that the Board voted on for the register. He said they would have their third reading tonight and he did not anticipate any problems.

Mr. Burroughs made a suggestion that the ordinance section that applies to the property to be included with the staff recommendation.

Mr. Carter also suggested that the Board develop a standardized survey card for each of the properties the Board recognizes to the register. Mr. Carter suggested a committee to develop the cards, including GPS coordinates, description of properties, and photos of all sides of buildings. Ms. Carine and Mr. Graham volunteered for the committee.

Mr. Strydesky asked about the accuracy of a Tax Map Number as an identifier for a cemetery. Mr. Emrick said he didn't feel that a survey needed to be done for the accuracy of the cemeteries, he mentioned that with the Tax Map Numbers attached to the cemeteries would help to identify that a

cemetery is on the property if that property was to be developed, thus helping the developer and the Board to use that space as best as possible.

**Cemeteries** -Mr. Emrick gave the Board a proposal of 9 properties for placement on the Register of Historic Places at the March meeting. He gave a description of each one including a small history of the cemeteries, the oldest graves, the number of graves if known, the homes, and any other pertinent information. This information was included in the Board members packets. Mrs. Thompson gave some interesting information of the condition of the Parker Cemetery and the work they had to do to clean the cemetery. She also gave the Board some historic information of the cemetery. Mrs. Thompson also gave historic information on the McNeil Farm. They are as follows:

- i. Long Cemetery
- ii. Buffkin / Turbeville Cemetery
- iii. Buffkin-Rowe Cemetery
- iv. Parker Cemetery (South)
- v. Nixon Cemetery
- vi. Parker Cemetery (North)
- 3. The McNeill Farm
- 4. The Watts Home
- 5. The Meade Tower

There was some discussion as to what style of homes should be designated to the register. There are some styles that are very common to the area and some debate as to whether or not they should be considered for the register just because they met the 50 year criteria.

**Horry County Guidelines – Handout –** Mr. Emrick gave a copy of The Secretary of the Interior's Standards for Rehabilitation and Guidelines for Rehabilitating Historic Buildings (Revised 1983) for the Board to discuss. He explained this is what the Board is currently operating under. He also gave them the copy of the guidelines that were never adopted, they are stricter.

**Countywide Historic Survey Update** – Mr. Emrick informed the Board that the survey was not currently ready. They were having some difficulties with tax map numbers in some districts.

## **NEW BUSINESS**

Mr. Emrick mentioned that Mr. Strydesky set up an interview with Diane De Vaughn Stokes on Southern Style.

Mr. Emrick and Mr. Klement will be on the show next Monday February  $25^{th}$  and it will be aired on Tuesday February  $26^{th}$ .

Mr. Strydesky also mentioned that if they were to write an article about what the Board is doing that his friend with Alternatives will print the article.
