The eastern portion of the County would require individual re-zonings. These rezonings to a Historic Preservation (HP) zoning classification would only be an overlay zoning district.

B. Mr. Thompson presented the 1990 Manual of Practice for Local Preservation Commissions to the Board and stated all members would receive a copy at the next meeting.
