### III. Vereen Gardens Update

IV. Economic Impact Report

Mr. Thompson provided all the members of the Board with a copy of an economic impact report created by Waccamaw Regional Planning and Development Council and Horry County to demonstrate the potential of the Vereen Memorial Historical Gardens.

- V. Grants
  - A. 1993/1994 PRT Grant

Mr. Thompson informed the Board that he was preparing a grant proposal for the 3.88 acres of property on the front portion of the Vereen Memorial Historical Gardens. Due to the fact there are not any reversionary clauses placed on the title it would appear the request for picnic tables, grills, benches, bike racks, etc. would be reasonable. The grant is a 50/50 matching grant totaling \$20,000.00.

B. HUD Grant Prospects

Mr. Thompson informed the Board that there may be additional programs sponsored by HUD to stimulate economic growth in South Carolina. Mr. Thompson also mentioned that he was made to believe that most of the qualifying requirements would be waived. This could assist in funding if clear title is not an issue for park development.
