




### INSTALLATION INSTRUCTIONS

1. PREPARE A CLEAN 16.25" W x 8.25" H ROUGH OPENING. (1 CMU BLOCK)
2. APPLY A BEAD OF HURRIBOND™ GRIP & SEAL OR EQUIVALENT ADHESIVE AROUND THE BACK OF THE FLANGE ON THE VENT FRAME. (FIG. 2)
3. POSITION THE FRAME INTO THE OPENING AND PUSH THE VENT COMPLETELY IN UNTIL THE FLANGE IS FLUSH AGAINST THE WALL.
4. RE-CHECK THAT FRAME IS SQUARE.
5. VENT DOOR COMES WITH COVER INSTALLED - IF NATURAL AIR VENTILATION IS DESIRED, REMOVE THE COVER BY PUSHING THE (6) RIVETS FROM BEHIND AND PLACE IN STORAGE. FOR USE IN COLDER TEMPERATURES, LEAVE COVER ATTACHED.




