  - a. Mines/ponds shall be a minimum of 25 ft. from waters of the U.S. and State, unless a Clean Water Act 404 permit is issued by U.S. Army Corps of Engineers;
  - b. Mines/ponds shall be a minimum of 25 ft. from a property line unless a written agreement with an adjacent property owner is obtained; and
  - c. Permits or approvals may be required from SCDHEC and/or USDA for farm pond approvals.
