

The Horry County Board of Architectural Review met on July 26, 1988 at 7:30 p. m.

Present were: Steve Usry, Ruth Bell, Greg Martin, Bill Long, Jane Charles, Sharon Richardson and David Utterback.

The meeting was called to order by Chairman Usry.

Minutes of the last meeting were approved upon a motion which passed/carried. with a notation that Ruth Bell was absent.

Discussion was held upon the upcoming Workshop to be held in Charleston in September. The members requested that the next mailing include information on this trip.

Ms. Richardson gave an update on Corps of Engineer's involvement in the project.

Ms. Richardson also gave an update on the Freewoods Community Development Project.

Mr. David Utterback gave an overview of his survey progress to date. Mr. Usry expressed concern of the lack of the Board's involvement in the review of the work. He felt that too much of the work had been done by Archives and History. Eighty-five (85%) percent of the work has been completed to date.

The next meeting was scheduled for August 23, 1988 at 7:30 p. m.

The Horry County Board of Architectural Review met on Tuesday, June 28, 1988 at 7:30 p. m. in the Conference Room of the Horry County Planning Department. Mr. David Utterback was present as the consultant for the Architectural and Historical Survey.

An overview of the walking tour of the Vereen Memorial Historical Gardens was discussed by Chairman Usry.

Ms. Sharon Richardson gave an update on staff contacts with South Carolina Coastal Council.

A Grants Update was provided with a copy of the letter from the South Carolina Department of Parks, Recreation and Tourism read. Other possibilities of grants discussed were Bingo Tax monies, Accomodations Tax monies, and Community Development Block Grant monies.

Mr. Joel Carter gave a report on the meeting held on the information pamphlet. Mr. Carter stated that minutes of the meeting would be made available.

Mrs. Jane Charles gave a report on the Workshop on Local Preservation Commissions. She stated that the attitude of citizens is usually hostile and the workshop focused on how to deal with the situation. She also stated that the strength of the ordinance is paramount.

Discussion concerning the need for news releases and public education of needs for historic preservation was discussed with it being agreed that at the completion of the survey that a news release would be released with status, projects, goals and objectives.

Mr. David Utterback provided an update on the survey stating it is about 50% complete with 102 structures being identified thus far. The brochure was also discussed with a resolution that the Board of Architectural Review had no objections to David Utterback being authorized up to \$200 additional in the contract for additional format set-up.

It was agreed that the next meeting of the Board of Architectural Review would be July 26, 1988 at 7:30 p. m. There being no further business, the meeting adjourned at 9:30 p. m.

Minutes of the previous meeting were approved upon motion carried/unanimous. Mr. Carter requested that the minutes be sent with notices of the meeting.


The By-Laws were approved upon motion/carried/unanimous.

The meeting was called to order by Chairman Usry.

Minutes of the last meeting were read and approved upon motion/carried.

Discussion centered around a letter that had been received from PRT which stated that all heirs of the Vereens need to sign a deed for the Vereen Memorial Gardens to prove that the property would not revert. After discussion, it was recommended that Greg Martin draft a letter for John Breeden's signature stating that Horry County would refund the grant monies if the property were to revert. This was approved upon a motion which carried unanimously.
