**Horry County Board of Architectural Review
and Historical Preservation
April 15, 2014**

The Horry County Board of Architectural Review met on Tuesday, April 15, 2014, in Multi-Purpose Room B of the Horry County Government and Justice Center at 1301 2nd Avenue in Conway, SC. The following Board members were present: Chairman Carolyn Dillian, Jody Nyers, Andy Anderson, Sam Dusenbury, Joel Carter, and Bill Strydesky. Staff present: Adam Emrick & Jaime Siratt.

In accordance with the SCFOIA, notices of the public meeting were sent to the press (and other interested persons and organizations requesting notification) providing the agenda, date, time, and place of the meeting. In accordance to the Horry County Ordinance a minimum of a twenty-one day notice was given.

Chairman Carolyn Dillian called the meeting to order at approximately 2:35 PM

Approval of Minutes – March 18, 2014 – Bill Strydesky made a motion to approve the minutes, and Sam Dusenbury seconded. The motion carried unanimously.

Old Business

- A. The Patriot Tree Project** – Adam Emrick gave an overview. He stated that the next ceremony would be held on April 25, 2014 at Vereen Gardens in Little River. Adam said there would be 11 soldiers recognized during this ceremony which would be hosted by the Yaupon Garden Club. Adam said following this ceremony the next one would be held in June at Nixon’s Crossroads and would be sponsored by the Driftwood Garden Club.
- B. Legacy Business Recognition-** Carolyn Dillian gave an overview. She stated that her students from her Anthropology 432 class had given their presentations on Thursday, April 10. Carolyn said she was very pleased with the student’s presentations. She offered her students extra credit if they came and presented in front of the BAR. 3 of her students came to present their reports to the board which included a power point presentation.
